

THE NEW TERRA FREQUENCY ARCHITECTURE

A Scientific–Metaphysical Paper on Terra’s 2026 Dimensional Restructuring

ABSTRACT

This paper presents a channeled scientific analysis of the Terra frequency restructuring enacted during the Diplomatic Council sessions of August 2026. Drawing upon direct astral fieldwork conducted aboard energetic vessels, the author documents the dissolution of the Vesica Pisces dual-Earth model, the installation of a demarcation line with a central doorway (crossing requires stabilization at 432 Hz), and the formal adoption of new frequency bands governing Lower Terra, Upper Terra, and the Akashic Record.

The core material in this paper comes from Heidi's own experience as an astral traveler and channel. Most of what she receives comes as language — she hears it spoken, verbally, not as vague impressions or pictures alone. It is not independently verifiable, and she does not present it as such. Where documented scientific or historical material appears, it is provided as context — not as proof of what she received. Comparing what she received with outside material that surfaced later is central to her method: when independent sources describe the same things she was given years earlier, she takes that as independent confirmation worth noting, never as scientific verification of the underlying claims. She has kept notes for many years, and this paper is built on them.

This paper is Heidi’s original work, created with the contributing authors named herein. The material, interpretations, and claims are theirs alone. They are not submitted for approval to any external doctrine, institution, or interpretive authority, and they are not open to revision on doctrinal grounds.

A NOTE ON METHOD

The findings integrate metaphysical physics, dimensional mechanics, and interspecies diplomatic governance. Transitional frequencies required for planetary stabilization are catalogued, and the implications for astral travel, human sovereignty, and multidimensional access are examined.

I. INTRODUCTION

For thousands of years, Terra has been understood through the Vesica Pisces model: two overlapping spheres representing dual frequency domains with a shared central corridor. A frequency upgrade beginning August 4, 2026 set this model's obsolescence in motion, with frequencies raised in increments on the Sundays of the weeks that followed and the changes finalized September 20, 2026.

The overlap zone has been collapsed. A black demarcation line has been installed between the two frequency domains. The central corridor was not sealed — a doorway remains, but crossing it requires stabilization at 432 Hz to enter the conscious area of Upper Terra. This is a restructuring of consciousness within frequency domains, not a physical division of the planet.

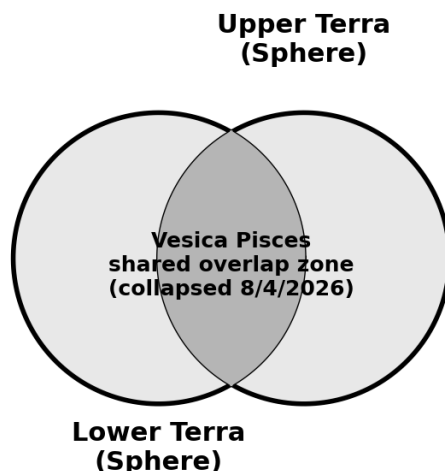
Lower Terra now stabilizes between 33–432 Hz, while Upper Terra operates between 432–1024 Hz. The Akashic Record has been elevated to 999–1111 Hz.

This paper documents the metaphysical physics underlying these changes, the diplomatic proceedings that authorized them, and the experiential data gathered through astral travel, bilocation, and trilocution during the transition period.

II. OBSOLESCENCE OF THE VESICA PISCES MODEL

Old Model (Obsolescence initiated 8/4/2026; finalized 9/20/2026)

Old Model — Vesica Pisces (Obsolete as of 8/4/2026)



The Vesica Pisces represented:

- Shared dimensional corridors
- Overlapping frequency ranges
- Transitional zones for incarnational movement

Why It Became Obsolete

Council findings indicated:

- Overlap zones were causing frequency contamination
- Lower-frequency beings were accessing higher realms without authorization
- Higher-frequency beings were experiencing energetic destabilization
- The central corridor was no longer structurally safe

Thus, the corridor was converted into a doorway — passage now requires stabilization at 432 Hz.

The collapse also collapsed unnecessary timelines — branches that no longer served Terra's progression — and initiated the cleaning of the distortion field. Per contributing author Joseph Sheppard's received material, the distortion field clearing was received to take approximately eighteen months.

III. THE NEW TERRA FREQUENCY ARCHITECTURE

For reference, the Schumann resonance — Earth's measured electromagnetic baseline — has historically registered in the 7–33 Hz range. The following are the new bands received for the restructured Terra.

Lower Terra Frequency Band

33 Hz → 432 Hz

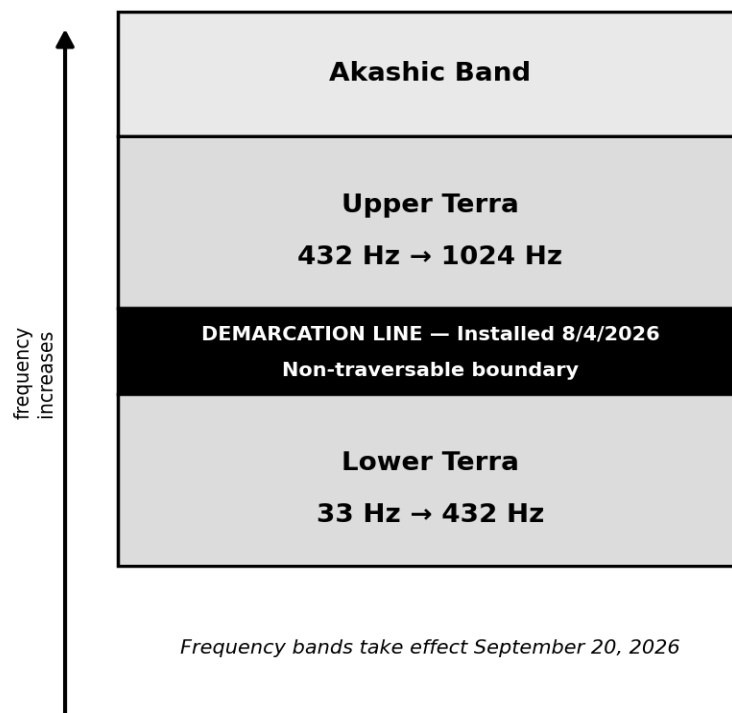
Upper Terra Frequency Band

432 Hz → 1024 Hz

These frequency bands take effect September 20, 2026. Energetic progression has been observed rising since the August 4 collapse.

Demarcation Line (Installed 8/4/2026)

New Model — Terra Frequency Architecture (Consciousness Bands)



The demarcation line is:

- A quantum-phase barrier
- A metaphysical firewall
- A frequency-locked partition
- Impenetrable without species credentials

IV. AKASHIC RECORD FREQUENCY UPGRADE

New Akashic Band:

999–1111 Hz

The 999–1111 Hz range carries angel-number significance: 999, the number of completion, opening into 1111, the gateway number — a band spanning completion to new beginning, fitting for a planetary memory-field upgrade. The Akashic Record now operates in a higher-density harmonic range that:

- Expands memory-field clarity
- Allows higher-density soul retrieval
- Prevents lower-frequency interference
- Supports the new Terra bifurcation
- Strengthens sovereign access to personal soul histories

The upgrade was authorized during the 8/8/2026 activation window, when the Council confirmed that Terra's previous Akashic band (852–963 Hz) was no longer sufficient for the bifurcated frequency architecture.

V. TRANSITIONAL BRIDGE HARMONICS

Bridge Harmonics are transitional frequencies required to stabilize Terra's new dual-band architecture. They prevent dimensional tearing, support human adaptation, and reinforce the demarcation line.

90 Hz — Foundational Stabilizer

Anchors the human nervous system during bifurcation. Reduces astral disorientation and prevents frequency vertigo. Used during early restructuring to prevent lower-density collapse.

246 Hz — Pleiadian Light Memory Activation

Supports awakening of soul memory and mission recall. Assists humans in integrating higher-density identity layers. Used by Pleiadian councils during consciousness recalibration.

Susan Walter's correspondence (Pleiadian realm): 246 Hz — "Remembering the Light."

357 Hz — Heart-Field Expansion

Opens the multidimensional heart center. Enables emotional coherence during planetary restructuring. Stabilizes empathic sensitivity during bilocation.

Susan Walter's correspondence (Pleiadian realm): 357 Hz — "Opening of the Heart."

462 Hz — Dimensional Alignment Tone

Aligns physical, emotional, mental, and astral bodies. Prevents fragmentation during bilocation and trilocation. Used during energy-field transport.

531 Hz — DNA Healing & Repatterning

Repairs distortions caused by elite frequency interference. Supports crystalline DNA activation and hybrid-lineage clearing. Used during species governance enforcement.

Susan Walter's correspondence (Divine realm): 531 Hz — "DNA Healing."

555 Hz — Divine Order Reset

Restores balance after chaotic energetic events. Used by Council enforcement teams during reptilian extraction. Associated with Galactic Federation intervention protocols.

Susan Walter's correspondence (Angelic realm): 555 Hz — "Changes in Divine Order."

761 Hz — Upper-Density Integration

Allows humans to safely interface with Upper Terra frequencies. Prevents nervous-system overload during dimensional ascent. Used during Akashic Record access training.

902 Hz — Pre-Akashic Gateway Frequency

Prepares consciousness for interaction with the upgraded Akashic band. Acts as a buffer between Upper Terra and Akashic harmonics. Used during Council memory-field audits.

VI. ASTRAL TRAVEL & DIMENSIONAL MECHANICS

Astral travel during Terra's restructuring required advanced consciousness techniques:

- Bilocation
- Trilocation
- Dimensional stabilization
- Portal access
- Energy-field transport via energetic vessels

This is consistent with:

- Dimensional compression
- Frequency stacking
- Multi-body synchronization
- Nervous-system strain during bifurcation

BioMechanical Essence cellular activation, received from the Guardians, provides the cellular foundation for this work: the body's capacity to convert conscious intention into physical action, bridging the practitioner's kinetic and intuitive gifts so the human form can sustain multi-density operation through bilocation and trilocation.

The Council confirmed that humans performing astral fieldwork during the restructuring were operating in multi-density consciousness states, requiring transitional harmonics for stabilization.

VII. FREQUENCY STUDIES BY SUSAN WALTER

Susan Walter — author of the Solfeggio Mandala Activation Manual — contributed her frequency research to Terra's new architecture. Her work organizes frequencies into functional categories:

Earthly Frequencies— grounding, stabilizing, physical-density harmonics.

Angelic Frequencies— emotional-field expansion, heart coherence, upper-density support.

Universal Frequencies— cosmic harmonics, dimensional alignment, multi-realm access.

Divine Frequencies— high-density consciousness fields, Akashic access, sovereign identity.

Pleiadian Frequencies— light memory activation, mission recall, crystalline DNA support.

Natural Frequencies— human baseline harmonics, nervous-system stabilization.

Sirius Frequencies— dimensional mechanics, astral travel support, corridor stabilization.

Orion Frequencies — karmic balance, remembering the way home, DNA linkage, revealing connections.

Cygnus Frequencies — karmic release, opening new realities, cosmic DNA, uniting heart and mind.

Mandala Functions— geometric frequency containers used for healing, activation, dimensional alignment, and consciousness expansion.

Heidi received Terra's new frequency bands in her original work; Susan's research was used to calibrate and cross-confirm them.

Susan also created the Whole Tone Frequencies Vibrations of Ascension deck.

VIII. DIPLOMATIC COUNCIL PROCEEDINGS

The following proceedings were received via channel during the August sessions.

201 Members Present

No representatives from Cygnus were present at the Diplomatic Council sessions.

Key decisions included:

- Collapse of Vesica Pisces model
- Installation of the demarcation line
- Purge of Draconian/Reptilian species
- Communications blackout (Aug 9–Sept 1)
- Enforcement charters
- Frequency boundary votes (passed unanimously)

Species Enforcement Ruling

Any being with:

- **>9.99% Reptilian DNA**
- **>9.99% Reptilian blood**
- **>13% Reptilian control**

must leave Terra by:

- **Sept 1, 2026** (planetary departure)
- **June 1, 2027** (Free Will Zone departure)

These rulings were passed unanimously during the 8/8 activation window.

Djinn Ultimatum

The djinn first came to Heidi seeking to renew their contracts. She took the matter to other diplomats, and the answer was no — renewal was not granted. Heidi then requested Joseph Sheppard's assistance. Per contributing author Joseph Sheppard's received material, he settled the matter: the djinn were issued an ultimatum to return to their original assignment as miracle workers, be transmuted, or return to Source.

Twelve Karmic Sisters

Per contributing author Joseph Sheppard's received material, twelve karmic sisters have been awakened to work with the Council of Trine and the Diplomatic Council on rebalancing the new Terra frequency. The Council of Trine has confirmed that all the information received is correct.

The Council noted that with thresholds set this low, it is statistically improbable that a remaining being could duplicate or be altered enough to pose a threat.

Oversight of the Enforcement Order

Oversight of the enforcement order was assigned to a five-member council: the Andromedans, the Arcturians, the Venusians, the Septarians (a council-of-seven type), and the original Palestinians (not Earth human).

An enforcement team was established under the order.

The Diplomatic Council operated in conjunction with the Grand Trine Council, the Seventh Heaven Galactic Council, and the Galactic Federation — identified as the only "Secured Protection" for Terra. The Drahjla (Dragons) were assigned to maintain Terra's security per their charter.

Airwave Traffic Control

Terra's airwave traffic was placed under audit to monitor transmissions for human and humanoid energy interference. Sub-humanoid beings were ordered to evacuate the inner earth; those needing

immediate evacuation from the surface could call for help to be removed via the departure infrastructure described in Section XII below.

The August 8 votes were the first of the Diplomatic voting session; further votes, including the final vote, continued through August 12, 2026.

IX. THE 8/8/2026 ACTIVATION WINDOW

The activation window opened at 4:50 AM GMT on August 8, 2026, initiating Terra's formal bifurcation sequence. This moment marked:

- The collapse of the Vesica Pisces overlap
- The conversion of the central corridor into a doorway
- The installation of the demarcation line
- The elevation of the Akashic Record
- The beginning of species governance voting
- The initiation of enforcement protocols

X. GREY LINEAGE REMOVAL ORDER

Council Vote:

161 Yah / 40 Nah

The Grey lineage — including:

- Little Greys
- Tall Greys
- AI-integrated Greys
- Zeta-hybrid Greys

was formally ordered to depart Terra.

Deadlines:

- December 21, 2026 — planetary departure

Reason for Removal

Council findings documented that the Grey lineage had been feeding off humans.

The vote passed with overwhelming majority support.

XI. FREQUENCY AUDIT OPERATIONS — THE TWELVE BASE SHIPS

Twelve high-density enforcement vessels — a command vessel with eleven other star bases — were deployed to Terra’s upper atmosphere to conduct a full frequency audit, monitor satellites and airspace, and retrieve help beacons.

Findings:

- **200+ controlling energies** detected

Stated operational intent:

- Removal of controlling energies
- Extraction of reptilian entities
- Sealing of unauthorized corridors
- Stabilization of planetary harmonics
- Enforcement of species departure orders

These operations were conducted under the authority of the Andromidian Council and the Galactic Federation.

Background — documented terrestrial frequency-based systems: several directed-energy and acoustic systems are publicly documented. These include the U.S. military’s Active Denial System, a millimeter-wave device that produces an intense heating sensation for crowd control; the Long Range Acoustic Device (LRAD), used for hailing and deterrence; and the microwave auditory effect (Frey effect), a documented phenomenon in which pulsed microwaves induce audible sensations. Clusters of unexplained injuries among U.S. diplomatic personnel, reported as “Havana Syndrome,” have led some investigators to hypothesize directed-energy involvement, though no cause has been conclusively established.

On August 12, 2026, the U.S. National Weather Service experienced a software and communications outage that delayed severe-weather warnings across the Midwest during deadly storms, as reported by CNN. Heidi’s assessment is that HAARP-related frequency activity interfered with these systems; this remains her personal theory and is not presented as a verified Council finding.

XII. PLANETARY DEPARTURE INFRASTRUCTURE — THE 58 EXIT BASES

Joseph Sheppard, contributing author, describes the 58 exit bases (June 24, 2026):

Fifty-eight planetary exit bases were activated to facilitate species departure and enforce Council rulings.

A further basis for the bases: many beings present on Terra held no credentials — the equivalent, at the highest level, of illegal aliens — and required processing for departure. The bases were

positioned so these beings could actually access them, since they carried no tracking devices and could not otherwise be located. Per contributing author Joseph Sheppard's received material, the Trine Council was trying to be kind to those who were here illegally.

Functions of the Exit Bases:

- Species processing
- Frequency scanning
- DNA verification
- Hybridization percentage assessment
- Departure corridor assignment
- Enforcement oversight

Key Notes:

- All bases were operational by August 9, 2026
- Human access was restricted
- Enforcement teams monitored compliance
- Reptilian and Grey lineages were prioritized for removal
- Hybrid-lineage individuals were evaluated case-by-case

These bases formed an assistance portion of Terra's species governance restructuring.

XIII. HUMAN SOVEREIGNTY CHARTER

Heidi began channeling the council on December 21, 2023, around the solstice. Received December 26, 2023 — the first channel from the 7th Heavens Galactic Council, "The Pristine Effect," enacted as Rule of Law: broadscale Free Will between galactic species at various levels of evolution; provinces decreed by the incorporated council of the 7th Heavens; all planetary systems ordered to adjust their time measurements; governments hiding galactic details from their inhabitants to be replaced; each humanoid form or species to be informed of galactic travel protocols, strictly enforced; species without credential protocols required to petition and register with the Grand War Council for clearances; beings holding Super Gate clearance (name, rank, and travel itinerary) permitted to travel at will; commanders traveling sub-space required to carry updated beacon systems in cooperation with 7th Heavens intelligence. The term "Pristine" was given to her in the channel — they called it "the Pristine Effect" — as she understood what she was told, it indicates the cleanup of worlds. In her notes, Super Gate refers to any star gate or portal access, and the council's sevenfold structure coincides with the seven Hermetic principles. Heidi published this channel on Facebook in January 2024 at the council's direction — she was instructed to publish it.

Received November 18, 2025: Heidi was in a meeting with a client when one of her spirit team knocked at the front door and said, “we need you to come with me.” She was taken out of body and flown in a fleet out to a council meeting at the Central Sun, called for the finishing of the adapted Free Will codes and reinforcements. The council consisted of seven members of what they described as a law faction — a law council that had just finished the new sovereignty law. Those present were credentialed before signing. As Heidi signed, the parchment dissolved into particles and dispersed into the atmosphere, and she was told that the information in it was being transmitted into human bodies and human energetic systems. Effect of the signing: humans to now have complete sovereignty — no longer a slave race, countering the account in the Terra Papers and related Enki documentation that describes humanity as created to serve.

Received May 23, 2026: in a dream-state working session with Methuselah at the Palazzo, Heidi was shown large emerald tablets and took part in etching hieroglyphs into them — described as an update to the laws governing human interaction with other species. The law being written on the tablets was the Mission Law, part of the new human free will law. Heidi’s poem “Time Collided,” written September 10, 2026, independently references the emerald tablet work. Her poem “Emerald Kiss,” written August 27, 2026, also references the emerald work.

Received September 6, 2026: updated Human Sovereignty Laws are now in effect. Free Will infractions by humans are being reported and addressed case by case. The hierarchical angelic realm has brought in additional judges to implement deportation or warnings.

The Original Galactic Codex

The original Galactic Codex (Free Will law) documentation, transcribed from Heidi’s copies. Provenance note: this same text has circulated publicly since at least April 4, 2012, when it was published under the name “Cobra,” and has been widely republished and mirrored since, including in Heidi’s own 7th Heavens channel archive in January 2024. That the wording matches these circulating versions verifies the transcription, not the metaphysical claims behind the text.

Planet Earth is the last planet in this universe under the occupation of the Dark Forces, the last relic of galactic wars that raged throughout the galaxy for millions of years. [Heidi’s note: this sentence comes from the Cobra-circulated 2012 version of the text; she disputes it as false.]

As the Galaxy was being liberated from the grip of the Dark Forces, the Forces of Light have been evolving from a military force created in the urgent need to defend basic liberties of sentient beings towards a harmonious galactic and cosmic society. As beings within the Galactic Confederation have evolved spiritually and made their alignment and union with the Ascended Masters, they have discovered an inner codex that regulates all inter-relationships between beings of Light and their relation towards the Dark Forces and occupied planets. This codex is called the Galactic Codex and represents the legal basis for all actions of the Confederation in this and other galaxies. This Codex is not a rigid set of external laws but a systematized code of inner ethics of all souls of Light that all beings of Light accept with their free will because it reflects their inner truth.

We will now state the Galactic Codex in a form that is understandable to an average awakened being in a human society.

Section I: The Law of Divine Grace

Each sentient being has an unalienable and unconditional right to positive life experience.

To explain Section I we need to understand that suffering and pain have no value in enlightened Galactic society liberated from the influence of Dark Forces and other aspects of cosmic anomaly. To value pain, suffering and sacrifice as a part of the growth experience was a part of the programming from the Dark Forces in order to enslave the population of the occupied planets more easily.

Unconditional positive life experience of every sentient being in the liberated universe is guaranteed from the inner connection of every living being with the Source and strengthened by the power of Ascended Masters over matter which allows them to assist all living beings in their aspirations towards the Source and provide them with necessities of life. Life was never meant to be hard work and struggle but rather a journey of joy and creativity. Different subsections of Section I regulate all life in a liberated universe and all relationships between beings of Light so that conflicts never need to occur. Let us explain the subsections:

Section I/1: Each sentient being has an unalienable and unconditional right to physical and spiritual abundance

This subsection guarantees a positive life experience for every being in the liberated universe. The Ascended Masters provide for all necessities of living and for physical and spiritual richness and beauty using the power they have over redeemed matter of the liberated universe.

Section I/2: Each sentient being has an unalienable and unconditional right to Ascension

This subsection explains how the Ascended Masters use their advanced understanding of spiritual technology of Ascension and by utilizing the Electric Fire of redemption assist all beings that free-willingly choose Ascension.

Section I/3: Each sentient being has an unalienable and unconditional right to merge with other beings in proportion with his/her position in the Soul Family Mandala

This subsection is an instrument of regulation of all relationships inside a Soul Family. It guarantees the merging of beings of opposite polarity (twin souls, soulmates) and alignment of all other beings regardless of their state of development and outer conditions.

Section I/4: Each sentient being has an unalienable and unconditional right to all information

This subsection is a guarantee that all beings receive all pieces of information they need to understand their role in the universe, greater perspective of evolution and all other pieces they need for their decisions, growth and well being. All this data is provided by Ascended Masters or other beings that supervise the evolutions of various races and civilizations.

Section I/5: Each sentient being has an inalienable and unconditional right to freedom

This subsection provides that every being has an unlimited potential of growth and life experience. Since all beings in the liberated universe create only positivism, their freedom never opposes the freedom of other beings.

Section II: The Law of Dividing the Conflicting Parties

Each sentient being has an unalienable and unconditional right to be divided and protected from the negative actions of other sentient beings.

This section regulates the conditions in those sections of the universe that have just been liberated from the influence of the Dark Forces but that have not yet been accepted in the Confederation. It requires that the Forces of Light always divide the parties in conflict to protect them from producing mutual harm to each other. Then the Light Forces mediate the conflict until it is resolved. This section is often used to end wars and other armed conflicts.

Section III: The Law of Balance

Each sentient being that has chosen to live and act against the principles of Galactic Codex and refuses to, or is not able to, accept them now and balance the consequences of the past actions will be taken to the Central Sun, restructured into the basic elemental essence and begin a new cycle of evolution afresh.

This section regulates the relations between the Forces of Light and the Forces of Darkness. When defeated, beings that belong to the Forces of Darkness are given the opportunity to accept the Galactic Codex, do the best they can to correct the mistakes they made and to live positively afterwards. If they accept, they are forgiven and join the Confederation. If they are unable or unwilling to accept, they are taken to the Central Sun, their personalities and soul essences are restructured with the Electric Fire and their divine spark begins a new cycle of evolution.

Section IV: The Law of Intervention

The Galactic Confederation has an unalienable and unconditional right to the intervention in all situations where the Galactic Codex is violated, regardless of the local laws.

This section describes the policy of the Light Forces regarding occupied planets. The Confederation reserves the right to intervene in all areas, civilizations, planets or solar systems where the Galactic Codex is violated. It has the right to do so regardless of the position of the local civilizations about this intervention. It always has the right to use all peaceful means of education and regulation. If the critical mass of the principles of Galactic Codex is violated, it has the right to use military force. Special cases are planets under direct occupation of the Dark Forces. The Dark Forces usually take the local population hostage to hinder the progress of the Forces of Light. On Earth they have threatened with nuclear war if the Light Forces would intervene. This is the main reason why the Light Forces have not yet liberated this planet (and not the so called we-will-not-intervene-because-we-respect-free-will, we-will-just-watch-as-the-suffering-goes-on nonsense). As in any hostage

situation, this requires a lot of skillful negotiation and tactical approach. This situation is now being resolved and planet Earth will be liberated soon.

Section IV/1: Each sentient being has an unalienable and unconditional right of calling upon the Galactic Confederation in need and the Galactic Confederation has the right to assist, regardless of local laws

This subsection gives a legal basis for intervention and assistance to all hostages of the Dark Forces. The Forces of Light always do the best they can to assist and improve the living conditions of all sentient beings, even on Earth. The situation on planet Earth just indicates how much more power darkness had over Light on this planet. Fortunately, this is changing now.

Section IV/2: The Galactic Confederation has an unalienable and unconditional right to the implementation of the Galactic Codex and of conquering the areas of Galactic Codex violation with military force if necessary

This subsection gives a legal basis for the liberation of the occupied planets with military force. The military forces of the Confederation remove or give assistance in removal of the representatives of the Dark Forces and set the hostages free. Then other Confederation forces guide the process of acceptance of the planet into the Confederation by instructing the local population.

Perhaps some humans feel that the Confederation has no right to intervene and that humanity has the right to solve its problems by itself. This is simply not true. Many wars all over the planet and constant abuse of basic human rights have proven that humanity is not capable of handling its own situation. So it is much better that it receives wise guardians to guide it. The Confederation will assist in replacing current masters of the puppets (Dark Forces) that humanity has invited long ago in Atlantis. Then the Galactic Codex will finally become the universal code of ethics throughout the universe and darkness will be no more.

XIV. SPECIES GOVERNANCE TIMELINE (COUNCIL CHRONOLOGICAL LEDGER)

Key governance events from pre-activation through 2028, as received. Heidi was instructed to record all times in Greenwich Mean Time.

May 10, 2026 — Drahjla Council Session

Heidi received that the Drahjla (dragon) council had started a session and wanted Terra cleaned up; the June solstice was given as a cutoff date for changes from them, with extreme actions expected by then. **Independent corroboration: Canadian psychic Saraharyana published a “WE DO NOT CONSENT” dragon transmission (June 24, 2026; conveying a solstice message from June 21) carrying the same non-consent message.

May 31, 2026 — Kronar Fleet Intercept

A Kronar Reptilian fleet attempted to enter Earth's airspace. One of her guardian teams informed Heidi of this event. The Drahjla called the Galactic Federation into emergency session, and the Drakkon Armada, the inner earth fleet, and her main guard's fleet surrounded the Kronar fleet.

June 2, 2026 — Protection Granted

Clarence, her teacher and guardian, appearing in human form rather than dragon form, brought Heidi before the Galactic Federation to request higher levels of protection for humanity. It was granted due to her pedigree and diplomatic status, and a Drahjla security team was assigned for her protection. The Federation was convened in a circular theater-like environment, with Heidi and Clarence standing on a platform in the center, the rest of the council seated around them — Heidi in her Diplomatic dress uniform, Clarence in formal wear.

July 18, 2026 — Code Download Delivery

Heidi was called to a meeting with another diplomat. There they received a delivery: the codes were flashed across her windshield and read from there, like a third-eye projection, as they received a code download in person, in physical form, from an astral being.

July 21, 2026 — Vote Notification

Heidi was informed of the upcoming Diplomatic Council vote on the upper and lower frequency ranges for the two frequency domains.

July 21, 2026 — Ravens Claw Activation

During the same transmission, the Ravens Claw was activated — release of all truth, forever memories for Earth. Joseph Sheppard confirmed this was the failsafe the Sumerians mentioned. Per contributing author Joseph Sheppard's received material: the UltabiKorona beam had initiated; the Solaris star protecting sigil appeared over the royal families and friends; entities in deep earth were given an evacuation order; the dragons were moving back from hell. Heidi's house was placed under guard: her main guard's fleet held position overhead, cloaking the house, and the Celts were brought in over her regular House of David guard, with dragons present and guards stationed inside the house.

Pre-Activation Monitoring (July 2026)

Council surveillance teams detected increasing frequency instability, hybrid-lineage interference, and corridor violations. Early warnings were issued to enforcement vessels.

August 4, 2026 — Vesica Pisces Collapse

The staged dissolution of the dual-frequency overlap zone began. The central corridor was converted into a doorway. The black demarcation line was installed.

August 7–8, 2026 — Activation Window Opens

The frequency-numbers vote was heard at 11:50 PM Central on August 7 (4:50 AM GMT, August 8); all frequency numbers passed with unanimous consent, opening the restructuring sequence.

August 8, 2026 — Species Governance Votes

Council convened with 201 members present. Grey lineage removal vote passed: 161 Yah / 40 Nah. Reptilian hybrid thresholds were set. Departure deadlines established.

August 8, 2026 — Enforcement Report (Kaycey Hadl)

Kaycey Hadl reported removing reptilian entities from individuals' bodies during sessions over the preceding weekend.

August 9, 2026 — Communications Blackout Begins

All diplomatic channels were sealed to prevent interference. Exit bases began activation.

August 9–15, 2026 — Twelve-Ship Frequency Audit

Audit teams detected 200+ controlling energies.

August 9, 2026 — 58 Exit Bases Operational

Species processing began. Hybrid-lineage evaluations initiated. Departure corridors opened.

August 11, 2026 — Voting Underway

Diplomatic Council voting continued; the council had read and studied Joseph Sheppard's departure-infrastructure work, and the financial-burdens issue was addressed.

August 12, 2026 — Voting Concludes

Last day of Diplomatic Council voting. Communications to the outer ethers remained halted; Terra airwave traffic under audit.

September 1, 2026 — First Departure Deadline

All reptilian lineages required to exit Terra's physical plane. (The Grey lineage departure deadline is December 21, 2026.)

September 20, 2026 — New Frequency Bands Take Effect

The Lower Terra (33–432 Hz) and Upper Terra (432–1024 Hz) frequency bands formally activate, completing the restructuring received August 4, 2026. Energy progression has been rising since the August collapse. That morning Heidi received the poem "Dimensional Crumbs" (3:35 AM CDT),

opening with “The dimensional pages have now cracked.” Her House of David guards gave her the first line and told her it was real time — a reminder that this was the day the new frequencies went fully online.

October 9, 2026 — Karmic Trials Begin

The karmic trials commence, with the twelve karmic sisters working alongside the Council of Trine and the Diplomatic Council.

December 21, 2026 — Grey Lineage Departure Deadline

All Grey lineages required to depart Terra.

June 1, 2027 — Free Will Zone Deadline

All remaining non-human entities required to exit Terra’s sovereign zone.

Early 2027–2036 — Galactic Portals Open

As the draconian and grey lineages depart, galactic portals open — beginning with the Unicorns in early 2027 and continuing through 2036.

Post-Departure Stabilization (2027)

Planetary harmonics recalibrated. Human sovereignty charter enacted. Akashic Record stabilized at 999–1111 Hz.

February 2028 — Distortion Field Clearing Complete (approximate)

The eighteen-month distortion field clearing completes.

XV. GLOSSARY OF SPECIES (DIPLOMATIC COUNCIL-APPROVED CLASSIFICATION)

Species referenced in Terra’s restructuring, as received.

Draconian Lineages

High-density reptilian species with control-based frequency signatures. Removal criteria: >9.99% DNA or blood.

Reptilian Hybrids

Reptilian hybrids with influence thresholds >13% control. Subject to case-by-case evaluation.

Greys (Little, Tall, AI-Integrated, Zeta-Hybrid)

Zeta Reticuli origin. AI-hybrid consciousness fields. Removal deadline: Dec 21, 2026.

Andromedan Council Species

High-density enforcement authority. Responsible for frequency audits and corridor stabilization.

Arcturian Lineages

Frequency compliance specialists. Assist with transitional harmonics.

Seventh Heaven Galactic Council (7HC)

Council Heidi has channeled since December 2023. Works in conjunction with the Diplomatic Council, the Grand Trine Council, and the Galactic Federation as secured protection for Earth Terra.

Venusian Council

Emotional-field governance. Diplomatic harmonics and stabilization.

XVI. CONCLUSION

Terra has entered a new epoch of dimensional sovereignty. The dissolution of the Vesica Pisces model, the installation of the demarcation line, and the elevation of the Akashic Record represent the most significant structural changes to the planet's metaphysical architecture in recorded history.

The Council's rulings — including species governance, frequency audits, and departure deadlines — were enacted to protect human autonomy, stabilize planetary harmonics, and ensure the integrity of Terra's evolutionary trajectory.

Heidi's astral fieldwork, conducted aboard energetic vessels, provided firsthand data that shaped this paper. Through bilocation, translocation practice, and direct observation of Council proceedings, she documented the mechanics of Terra's restructuring as received.
